\* Ethics training must focus on ethical behavior and responsibility as related to the American Counseling Association's Code of Ethics or the Center for Credentialing and Education's Approved Clinical Supervisor (ACS) Code of Ethics.

Contact Hours - Forty contact hours of continuing education\*, including a minimum of three contact hours of ethics, are required within the two-year license renewal period. However, in the cases of newly issued licenses in which the initial renewal periods are less than two full years, 30 contact hours, including a minimum of three contact hours of ethics, are required. Contact hours equal the number of actual clock hours spent in direct participation in a structured education format as a learner.

One Continuing Education Unit (CEU) = 10 contact hours

One Semester hour of credit = 15 contact hours

One Quarter hour of credit = 10 contact hours

\* LPCS renewals must provide additional documentation of a minimum of ten (10) contact hours of continuing education training related to professional knowledge and competency in the field of counseling supervision.
